Introduction

There were 283 completed surveys submitted online and in paper form. Not everyone answered all the questions; hence, the "respondents" for the individual data below are based on those who responded to that question. When the number of respondents is not cited, the data are from all submitted surveys.

Public Safety

Crofton PD Performance – Of 275 respondents, 66% said they have seen CPD patrolling their neighborhood, and 34% said they have not. Of 272 respondents, 16% feel that the safety patrol coverage of their neighborhood is Excellent, 46% said Good, 25.5% said Fair, and 12.5% said Poor.

Of 275 respondents, 76% said that they have seen the CPD enforcing traffic, and 24% said they had not. Of 272 respondents, 15% said that CPD traffic enforcement was Excellent, 46% said it was Good, 27% said Fair, and 12% said it was Poor.

Of 271 respondents, 69% felt that, overall, the CPD is keeping the CSCBD safe, while 18% had no opinion on the matter, and just 13% thought that the CPD is not keeping the CSCBD safe.

Crofton PD Services – 30% of residents reported being aware that CPD provides home security checks. 47% are aware that CPD does wellness checks. Less than 4% were aware that the CPD can sign off on vehicle repair order tickets.

Of 275 respondents, 77% were aware of CPD's Community Outreach Programs and 23% were not. Of those respondents, 41% wanted to see more community outreach programs, 43% wanted to keep the programs the same, 11% had no opinion, and only 5% wanted to see fewer community outreach programs.

Crofton PD Staffing – Regarding CPD staffing, there were 255 respondents:

- 38% felt that we should maintain our police force at five officers;
- 16% felt that we should add one officer to extend coverage from 7:00 PM to midnight, five days a week:
- 20% felt that we should add two officers to extend coverage to include some weekend or overnight patrols;
- 20% felt that we should have 24/7 coverage, which may require three or four new officers; and
- 6% selected "Other"

The majority of other comments wanted us to keep the force at five officers, but change scheduling to include weekend and overnight shifts. Three folks said to get rid of the entire police force.

Grounds Maintenance

Hardy Field - 25% of 273 respondents reported having visited Hardy Field.

Picnic Shelter – Of 81 respondents, 24% said they would make use of a shelter and grill at Swann Park, 44% said they would not, and 32% responded that they had no opinion.

Grounds Maintenance – Of 181 respondents, 33% felt that the CCA's ground maintenance was Excellent, 60% said Good, 7% said Fair, and less than 1% said Poor (in fact, just one person picked "Poor").

Use of the Forest Reserve – Regarding the installation of a walking path around the forest reserve, there were 185 respondents:

- 52% selected yes, put the path in. When the forest matures, it will be a great place to take a walk.
- 33% selected, no, leave the growing forest to the animals and let it grow wild.
- 15% had no opinion on the matter.

Cherry Trees – 202 responded to the question regarding the Yoshino cherry tree planting program.

- 64% think this is a good idea and should be continued as planned.
- 22% believe this is a great idea but pick up the pace and add more to the annual budget to get it done faster.
- 8% had no opinion on the matter.
- 6% said that they are not fond of the idea and don't think it should be a priority.

Parkway Benches – Regarding the placement of benches around Crofton Parkway, there were 273 respondents. 71% supported this program, while 17% said no, and 12% had no opinion.

Communications

E-Advocate – Of 278 respondents, 76% reported receiving the E-Advocate, and 24% said they did not. 86% of respondents who said they receive the E-Advocate reported reading it.

The Advocate – Of 271 respondents, 88% recall receiving the Advocate in the last year, while 12% don't recall receiving it. 92% of the respondents who recall receiving the Advocate report reading it.

Of 266 respondents, 47% said they would like to see the Advocate move to an e-book format, while 29% said no, they would not, and 24% had no opinion. (Note: The analyst observed that the "No's" largely came from retired people over 65 years old, and many of them are the same folks not receiving the E-Advocate.)

Email – Of 270 respondents, 57% reported receiving email messages from the CSCBD, while 43% did not. Of 187 respondents, 43% always read email messages from the CSBD, 36% usually read them, 6% read them sometimes, and 15% do not read them. Of 164 respondents, 96% said that the quantity of email messages from the CSCBD is about right, while 4% said that messages were too frequent.

CCA Website – Regarding use of croftoncommunity.org, there were 269 respondents, of which 4% visited the site weekly, 12% visited the site in the last month, 38% visited the site in the previous year, and less than 1% visited the site daily. 45% have never visited the website.

Of 154 folks who have used the website, 15% said they always find what they are looking for, 47% said they usually find it, 27% sometimes find it, and 11% said they don't find what they are looking for. Of 146 respondents, 78% reported that the website was easy to navigate, and 22% said it was not.

CCA Advocacy & Covenants

Advocacy – Of 273 respondents, 54% were aware of our advocacy programs, and 46% were not. Of 260 respondents, 67% said they have never been to a CCA meeting, and 33% said they had.

Covenants – When asked if the current covenants provide sufficient protection for residents, 37% of 254 respondents said yes, 22% said no, and 41% were not sure. Asked if the cost of moving to a single set of universal covenants was worth it, 66% of 225 respondents said no, and 34% said yes. When asked if they believe that current covenant enforcement is adequate, out of 250 respondents:

- 28% said no, the CCA should be *more* aggressive in its enforcement,
- 4% said no, the CCA should be <u>less</u> aggressive in its enforcement,
- 37% said that they were unsure, and
- Less than 1% said no.

Of 243 respondents, slightly less than 8% had ever been party to a covenant complaint.

Recreation

The CCA currently produces 20 community events each year, which include eight summer concerts. Of the current programs, we learned the following:

General Comments

Q (66) Do you have any ideas, suggestions, or comments that you would like to share with the CCA Board and the CSCBD staff?

- 1. Better enforcement of crosswalks. Too many people speed through when walkers/people are in them.
- 2. I have lived here since 1977, and while many things have changed, it's still a great community, especially for families, and I would recommend Crofton to anyone.
- 3. Would love to see Village Green revitalized with a restaurant the community could enjoy!
- 4. Covenant Enforcement? Are you kidding/ School bus speeding. I am offended by flags such as upside-down flags or others with a political message, such as the "Don't tread on me" one.
- 5. No, the Board and staff appear to do a very good job under the resource circumstances allowed. Thanks.
- 6. (Re: Covenant Enforcement) Found my situation was being talked about at a neighborhood senior center, so much for privacy.
- 7. As the world and people get crazier, I think Crofton should still strive to maintain a small-town vibe. We can't seem to control zoning and other issues beyond our boundary, but it would behoove us to do our best to improve our part of the county. The county doesn't help us much!
- 8. Thank you for making the triangle a wonderful place to live!
- 9. Have Crofton police patrol the ridiculous parking violations at Creative Gardens.
- 10. Stop placing large signs (and allowing others) in the median in front of the Prince of Peace Church. It blocks line of sight for Parkway traffic trying to make a left turn onto Crawford Blvd. when coming North on that part of Crofton Parkway.
- 11. Noise ordinance violations + runners/bikers/walkers on the wrong side of street/middle of street + no reflective gear.
- 12. Speeding cars. We need a mailbox back at the Village Green! Campers parked along the parkway that never move & we can't see around.
- 13. Crofton inside the triangle remains a wonderful place to live, but keep tabs on crime and slow down the speeders.
- 14. To suggest that there is any covenant enforcement today is downright silly.
- 15. No chicken coops; more logic in what should make CBCBD a real community again!
- 16. Soooo many wonderful & memorable events, programs, & parts of everyday life that make raising a family here very special!
- 17. I really wish we had NO parking of commercial vehicles on our streets. The boats, campers & trailers <u>look</u> <u>awful</u> & create blind spots for drivers and make our community look trashy.
- 18. I congratulate your hard work and provision of so many community events.
- 19. We moved here in 1975 & were never given a copy of the covenants. We found most from our neighbors!

- 22. Covenants need to be upgraded to the times, i.e., businesses from home ok, line drying in backyards ok, etc.
- 23. Doing business from a residential home that requires clients or customers to come to the house regularly should be prohibited.
- 24. I have lived in Crofton for 33 years. The first year, our car was stolen from our driveway, but everything since has been fine! Now at 94, I feel it is a great place to live. Since I only hope to be here a <u>little</u> longer, I'm not asking for any changes! My husband, John Walker, was Citizen of the Year about 10 years ago!
- 25. Not enforcing covenants affects all of our property value
- 26. Please enforce the illegal parking of campers, boats, trailers, and commercial vehicles on the Parkway, Layton, etc.
- 27. I support a move to limit the use of Crofton streets for the storage of RVs, trailers, boats, etc., and food trucks
- 28. We need more enforcement of noise violations, cars (vehicles with expired tags stored on streets)
- 29. Frankly, I'm unaware of any covenant enforcement in my neighborhood ever!
- 30. Marty Mows does an excellent job of maintaining the Crofton Common corners of 424 and Farlow.
- 31. Thank you for volunteering your time.
- 32. Keep up the good work!
- 33. "I really like the notion of this survey and am grateful for you putting it out here. However, the format is not very user-friendly...
- 34. 1. It does not depict how lengthy it is
- 35. 2. Navigation back/forth is cumbersome, 1 page at a time
- 36. 3. Must complete all in one sitting... means to "save" and return to it later
- 37. Would also like to be able to "Print" off a copy of the queries and my responses (there MAY be this option, but it does not appear to be)."
- 38. Do away with the covenants altogether...they are outdated (such as shed approval, no clotheslines, etc.). The covenants aren't being enforced, so just get rid of them. I'd rather see some enforcement done with the commercial vehicles and recreational vehicles parked all along the Parkway.
- 39. Thanks for all you do! We feel lucky every day that we get to live in this wonderful community.
- 40. I applaud the attempts to clear Crofton Parkway of RV vehicles, huge trucks and cabs, "abandoned" boats, and other unsightly vehicles. Also, some are appearing on side streets, making it very dangerous to drive on the streets. There's a truck with a hitch parked on Eton Way with a Texas license plate that is obviously a work vehicle that hasn't moved in years, making it dangerous to pass in order to drive up or down the street. The streets aren't wide enough to accommodate these types of vehicles. Also, when

coming to the stop sign on Duke of Kent, either to make a right or a left... is it one lane or two? If two, then how about painting a lane line (for lack of any other term)? People making a right are so intent on turning left alongside someone waiting their turn to make a left, that they rarely stop and aren't looking for people trying to cross the street, nor anyone making a turn at the Parkway. A lane line would be helpful

- 41. Provide more traffic coverage on the parkway. Vehicles are still using the community as a cut-through to bypass Route 3 traffic. Also, with 4 schools very close and our beautiful parkway, many kids and residents are out walking or on bikes. The speeds of vehicles and non-residents pose a significant safety issue.
- 42. Well, I am still puzzled to hear that there is a "Willows" park. Somehow, after living here for 47 years, I had never heard of such a park. Be nice to know exactly where it is.
- 43. Stop the county from granting parade/activity permits to non-CCA-supported organizations.
- 44. "Get the commercial vehicles off of Parkway, particularly between Duke of Kent and the main entrance to Crofton. For the past year, there has been a skimobile trailer holding two skimobiles on it, and it extends way too far into the middle of the road. Why is vehicle storage allowed along Crofton Parkway?
- 45. Have housing additions in FRONT of houses require architectural approval so design is consistent with neighborhood architecture. How the large contemporary addition to the front of house on the corner of Ellsworth and Eton Way ever got approved is beyond me. Cannot believe the plans were approved by anybody. It is an eyesore, given the design and materials used. If they had at least put in the traditional colonial style windows, that would have helped it to blend in more."
- 46. Thank you for this survey and for doing a great job! If you need me on any committee, please let me know. I don't have strong opinions or expertise, but I love Crofton and am willing to help as needed.
- 47. Keep up the improvements. Thanks.
- 48. Thanks for helping make our community safe.
- 49. Our community is very popular with people who don't live here and don't honestly take care of the community. We need to reduce commercial solicitations, signage, and vehicles parked along our roads that create blind spots and excess traffic. More speeding enforcement.
- 50. Trailer parked unhitched on Urby near the corner of Good Hope has not moved in over 12 months. No license visible. One flat tire. The cover is now rotting. Please remove.
- 51. The Police Department should be relocated to a separate, secure facility within the triangle. Residents lack private, accessible means of discussing private police matters with our PD. It's past time to get them out of the basement!
- 52. The growing eyesore of trailers, RVs, jet skis, etc., on the parkway is awful. It's like driving through a junkyard to get to homes. I don't understand why they're allowed to stay, unmoved, for months.
- 53. "I've already described my concerns about traffic in a previous section.
- 54. Thank you for making the survey available in the first place!"
- 55. "Cars moving along Crofton Parkway early in the morning is crazy, with cars exceeding the speed limit. As a regular walker around 5:30 AM, I am very aware of speeders and people blowing through stop signs."

- 61. As the general manager of another SCBD community with its own set of bylaws and rules and regs, I believe it is imperative to have consistent and enforceable covenants. I am no lawyer, but I would also assume it significantly increases liability. I would suggest a phased-in approach that addresses definable areas of priority in sequence over a number of years, which would allow for a more tolerable budget increase.
- 62. "Keep up the good work and thank you for all you do! ... please ask the golf course to clean up the edges and sidewalks around their property. Ask them to fix fences, please rejuvenate the old country club tennis courts (maybe CCA could take over them, renovate, and make them accessible to CCA residents), and hold the country club accountable and fine if necessary. Our cars have been hit several times, and our kids cannot play outside because of the cutthrough drivers from 3, trying to save time, which exceeds 45mph at times.
- 76. Please do something about the excessive cars, trailers, trucks, etc., that park long-term on the parkway!
- 77. Better utilization of the Village Green should be studied. Once the heart of the community, it's now an unknown area to newer homeowners.
- 78. You all are wonderful, but have a tough job. Thanks for all you do, and thank you for allowing the opportunity to offer feedback. When my children are a bit older, I promise to serve :) We love living in the Triangle!!
- 79. Yes, I'm not sure what area this falls into, but we live on Harcourt Avenue and backyards on both sides of this street face the Crofton Country Club golf course. While the Country Club is in many ways a good neighbor, many of the golfers who use the course are not. My children often hear golfers yelling obscenities, and our neighbors across the street have had many instances of golfers urinating in their backyards. If the CCA could open a dialogue with the Crofton Country Club and advocate for residents on this issue, it would be much appreciated.
- 80. i know it is a hard job- please keep up the good work and stay vigilant to make Crofton safe.
- 81. We no longer live in Crofton but still have a rental property there. So we are still interested in what happens in Crofton.
- 82. Covenant rewrite should include townhomes and condos instead of each neighborhood having a separate enforcement arm. The goal should be one Crofton. The rewrite should address real issues, not the color of the shutters or whether someone has a Winter wreath on their door after March 1st.
- 83. Crofton needs a community center
- 84. I really appreciate this survey. As I mentioned, I've lived here for decades. I've never seen anything like this before. It was informative and inquisitive at the same time. I doubt many people understand the organizations that oversee and support the Crofton community. This type of education needs to be repeated over and over again. Thank you for taking the time and effort to put this together.
- 85. Pass regulations to keep people from using the Parkway and neighborhood streets as storage for recreational vehicles and trailers
- 86. "If you are going to change any covenants, consider banning on-street parking. The community is ridiculous with all the vehicles on the street. It's embarrassing. Otherwise, great job on the community!!"

2. (Other)

I believe the Chief of Police should have the authority to increase the number of officers and hours they work. He's in a better position than I to determine community needs.

- 3. I believe that two more officers would be ideal, but that tax-wise, some might not want to go that way.
- 4. Most car thefts occur overnight. Daytime hours I feel secure, but overnight I am concerned.
- 5. Rotate the existing five officers for full coverage (include nights and weekends).
- 6. The more police presence, the better, in my opinion. I wholeheartedly support them, and we need them in our lives.
- 7. Change shift hours so most are at night rather than daylight hours.
- 8. I rarely observe Crofton PD officers do anything except manage traffic at the elementary schools, which is essential. I do not think we need five officers for daytime assistance only.
- 9. I do not feel a protective presence, but do feel appreciative of the office being there.
- 10. Use speed cameras on C.P. more cost-effective.
- 11. Crime happens anytime, but also at night, break-ins of cars in the Carlyle townhouse area.
- 12. Use speed cameras on C.P. more cost-effective.
- 13. Rotate work shifts to include some evenings/overnight or weekend coverage; work shifts (patrol) should be based on criminal activity or calls for service.
- 14. Need to improve staffing by the county of school crossing guards and free up our police officers.
- 15. We either operate as a 24/7 police dept or a community police dept which ='s more outreach programs (warm + fuzzy)
- 16. I appreciate the work of our officers. I do not think we need any more.
- 17. Is it possible for night patrols on Fri & Sat beyond 9 PM (assuming crime often happens on weekends), so some flexibility to give night hrs. v. day hrs.
- 18. I want officers to be increased if they are out on the street. Traffic enforcement is not taken seriously—time to step up the game.
- 19. Class instruction for <u>numerous</u> motorized bikes/scooters going in middle of cars in traffic-speeding also.

- 20. Important and expensive part of living here.
- 21. I'd prefer to hear what the PD feels is necessary for safety.
- 22. I would like to see the no-parking of commercial vehicles + recreation vehicles enforced, especially on Crofton Pkwy. It affects our property values.
- 23. I have no idea what the current coverage is. Is it only 5 days a week & certain hours? This is not clear to the community.
- 24. I don't know how to run a PD, but I know crime has gone crazy in Crofton.
- 25. Add one officer 7P-7A
- 26. Have visible technology to issue speeding tickets or more visible traffic stops btw 7 am 10 am & 3 pm to 8 pm
- 27. I think most crimes would occur after midnight. 24/7 patrol would help deter.
- 28. Beginning to notice more crime creeping in from the easy access Rt 3 provides.
- 29. Why can't the officers share cruisers? I feel that we (taxpayers) are providing personal vehicles since they can use them off duty.
- 30. Cut the current police force to 4 officers, then hire three new officers for 24/7 coverage.
- 31. Provide more traffic coverage on the parkway. Vehicles are still using the community as a cut-through to bypass Rt 3 traffic. Also, with 4 schools very close and our beautiful parkway, many kids and residents are out walking or on bikes. The speeds of vehicles and non-residents pose a significant safety issue.
- 32. Five officers seem enough to redeploy to cover more hours. See no need to increase the existing police force.
- 33. Why do we need to add more officers, if we want what we used to have, 7/24 patrols. Who pays for all the parade, special events coverage, and crossing guard support? They used to tag out-of-state vehicles and now trailers, even cars parked the wrong way.
- 34. I'd like to see more traffic enforcement from our existing officers for those who cut through Crofton or use our roads at excessive speeds.
- 35. Trailer parked unhitched on Urby near the corner of Good Hope has not moved in over 12 months. No license visible. One flat tire. The cover is now rotting. Please remove.
- 36. I've had some recent brazen thefts from my own front yard. Any surveillance we can provide would be greatly appreciated. We seem to have a lot of mischief going on, could be "homegrown" or could be outsiders to our community. Either way, I'd like our PD to have a handle on it.
- 37. We definitely need coverage late and overnight. The thieves come into our neighborhood starting around midnight to 3 am
- 38. Downsize the police department and hire a security company to do nighttime patrolling
- 39. The "fifth" officer could work the overnight shift and on weekends, or rotate that responsibility, or hire a half-time sixth officer for these hours.
- 40. I would suggest adding officers but also randomize their shifts. Increase the perceived presence through unpredictable patrols.
- 41. Perhaps things like the trunk or treat could be supported by one of the local churches or schools and a self-defense class could be offered by Anne Arundel County police so that our Crofton police can focus on policing our community. Honestly, trick-or-treating in Crofton has always been a family event with parents taking their children around to visit neighbors. I like the idea of these programs, but if they stretch resources too thin, I would rather have our police officers focus on policing and perhaps connecting in the schools.

- 42. Not having officers overnight and on weekends is a detriment to the community. Most of the shady things happen during those hours and the criminals can basically operate without fear since very rarely does Anne Arundel patrol through the neighborhoods overnight either. Even with the current staffing of 3-4 isn't there a way to at least cover more of the later night hours understanding leave and training plays a factor?
- 43. While I have seen traffic enforcement and patrolling I feel like it is not enough. If it is during the hours of 0600-midnight there should be police patrolling for speeding violations along the parkway and adjacent streets.
- 44. Crofton, like other municipalities in the area, has had a huge spike in theft from autos, stolen vehicles, etc, mostly occurring overnight. I've had my daughter's vehicle broken into on the Parkway. I would suggest adding 2 patrol officers and rotating mids. To be quite honest, I don't care too much about community policing (events, etc). I care about my car and property being safe overnight.
- 45. Since the only time I see them is when they are blocking the Parkway for parades or school drop-off/pick-up, I often wonder why we even have them at all. It looks like the county cars show up more often, and before Crofton does.
- 46. The roads bordering Crofton are frequently used for racing late at night, especially on Route 3 during the summer months. Couldn't we curtail this by supplementing our officers with mobile speed cameras? Cars with excessively loud mufflers operate early in the morning and late at night. Vehicles routinely run stop signs during all hours of the day and speed along Crofton Parkway. If adding more officer resources will help reduce the foregoing, you have my vote.
- 47. We should schedule existing staff so there is weekend day coverage. My consistent observation is that there are at least 4 Police cars at the Town Hall nearly all day long. There is no need to add a vehicle or new staff. Has the scheduling been reviewed independently to confirm that there is an efficient use of staff? Is the Chief included in the scheduling to the degree his responsibilities allow?
- 48. Or instead of 5 working at once, stagger the start and end times of the existing five officers to allow more coverage on nights and weekends.
- 49. And schedule as needed for high incident times.
- 50. Find the money elsewhere, lots of wasted tax dollars. There should be no increase in taxes.
- 51. Crime appears on the rise an engage police is a presence that I believe deters crime
- 52. I know a bit about shift work. With four patrol officers, there can be one on duty 24/7. 8-hour shifts, rotating four on, two off. Or less "friendly" variables. (I know with the minimum staffing of 4, there are gaps due to training, court, luncheons, etc.) 7 AM to 9 PM makes no sense, especially at 3/4 a million \$ per year. Bad guys want to do bad stuff at night? Just cruise by the station and count the parked cruisers, and you know if you're good to go. We already pay the county for police coverage disband the CPD, hold the county accountable, and save us a ton of tax dollars. You asked...
- 53. This is a tough question because we would love to hire a few more as the area grows, but so many people are already struggling with additional price increases in other areas.
- 54. Why can't AAPD help patrol Crofton? And allocate those funds back into the community, ie, playgrounds, green spaces, walkways within the community, Village Green revitalization?
- 55. I read the policing stats. It looks to me like our police department does an excellent job keeping our town safe. However, stats can be deceiving. If the police department feels like it is strapped, unable to keep up with the demand for its services, and/or the police department feels like there is unreasonable risk being taken by not having coverage at night or on the weekends, then I fully support adding additional officers and will happily pay my share for their services. As a town, we should not be taking undue risk if we can afford not to. That's just asking for trouble.

- 56. I feel that my money can be used for better purposes than funding a police force that does nothing.
- 57. Why do we need five police officers during the day? Why don't we just move officers' time during the late-night hours when more crime occurs?

- 59. I live at a dead end, so I do not see them very often, so I really have no opinion.

- 4. Need to crack down on speeding, failure to yield to pedestrians at crosswalks, and overall aggressive driving that has been running rampant.
- 5. We'd love to see the cut-through traffic deterred. Clubhouse Gate Rd. seems to be popular for those frustrated with Rt 3, as I am sure you are well aware! Would love some speed cameras.
- 6. Bicycle Patrols?
- 7. If there were any single issue that would ever make me consider leaving Crofton, it would be crime/safety.
- 8. I do not believe that we need five police vehicles. The vast majority of the day, there are 4 or 3 cars parked at Town Hall. 5 vehicles are too expensive to maintain.
- 9. More patrols in all townhouse communities.
- 10. Keep up the good work, and keep our kids and community safe.
- 11. More patrols in the townhouse communities.
- 12. More enforcement of speeding (especially on the parkway since there are children and families riding bikes, walking, jogging on the street and sidewalk).

- 33. I wonder the feasibility & cost of ebikes for officers to patrol parkway side streets
- 34. I am concerned about continued speeding on Crofton Parkway. I walk the pkwy most days & see early am, after school. And weekend speeding. A speed camera would be cheaper than another officer.
- 35. Please do something about vehicles that are parked on the street but never moved.
- 36. Police should be more present at night when the thugs are out
- 37. Any thoughts on rotating coverage shifts to have presence during the night when more issues or events are happening; less predictable coverage
- 38. I think officers could share cruisers to cut that cost.
- 39. No. Very happy.
- 40. Would like to see coverage overnight occasionally on the weekends, if possible.
- 41. So many drivers run the stop signs at the parkway & Duke of Kent put up a camera. Also, enforce the 25 limit, so many speeders.
- 42. Please be more active with traffic stops. There is too much speeding.
- 43. "While I'm grateful to see the CPD involved in community events which is a true benefit of being a resident and critical for sustaining an open dialog, the FIRST priority should be safety.
- 44. When we first moved onto the Parkway in 2000, there was a ROUTINE presence of officers running radar and issuing warnings/tickets. This was at multiple times of day, multiple days per week.
- 45. I truly cannot recall the last time I saw an officer running traffic checks. This is particularly disconcerting as the Parkway has become an absolute speedway. Particularly on Friday afternoons as people are cutting off Route 3 North through the Parkway. There are far too many children, bikers, citizens at risk.
- 46. Better still, I'd LOVE to see a speed camera installed between CWES and CES, near the Village Green (from what I've seen online, we qualify due to the juxtaposition of the schools).

- 47. I HAVE noticed an effort by Town Hall to have a social media presence and address concerns of our residents. That is a positive effort, though I imagine it would be hard to maintain given limited resources."
- 48. There is a missing question between this and the paper version. I am aware that the Crofton PD can sign off on vehicle repair order tickets, and I have used this service.
- 49. I believe we need enforcement of the 3-way stop on Duke of Kent and the Parkway. I have had to stop to allow cars to go as they run the stop sign. I never see any Officers checking the 3-way stop for motorists who run the signs.
- 50. They seem to be doing a great job. Crime is relatively low in Crofton, which is one of the biggest benefits of living here. Should crime rates begin to increase, I would advocate for increasing coverage (adding police officers), but for now, I think the five we have are adequate.

- 55. "More visibility of the police officers in the neighborhood. We need 24/7 coverage since it seems many of the crimes happen at night."
- 56. As a long-time retired resident, I spend a good portion of every day in the E-section and the Triangle area of Crofton. Despite the recent increase in Police officers and Police vehicles, I infrequently see Police patrols on Crofton streets. It seems to me that local Police presence is less frequent than in years past. I would like to see more Police monitoring the traffic flow at the 3-way stop intersection at the front doorstep of Police HQs/Town Hall. This can be a dangerous intersection, despite the fact that every vehicle approaching this intersection is required by law to stop. Can we spare one of our 5 Police officers to periodically monitor this intersection and enforce the rules of the road? On several occasions while using this intersection, after stopping and then proceeding into the intersection, I have had to abruptly come to a complete stop in the middle of the intersection as an approaching vehicle blows through their stop sign. This flagrant disregard for the rules of the road, threatening the safety of other motorists is an especially flagrant violation right at the doorstep of the Crofton Police HQs, with 4-5 police cars parked at the intersection. I realize there is Police presence during school hours, but can this presence be expanded?
- 57. Thank you to Crofton Police Dept for doing a great job with the limited resources. I know it's not easy!
- 58. The CPD presence and community outreach have risen exponentially over the past two years. Thank you!
- 59. I don't really have any.
- 60. The coverage needs to be extended to weekends and evenings. Having five officers should provide different staffing approaches during these times, especially with the existing MOU with AAPD.
- 61. I am wondering what the dept is considering in terms of trying to stop theft of cars and tires in the Lake Louise townhome area?
- 62. Speed cameras along Crofton Parkway and major incoming roads.

- 63. I see the Crofton Police frequently on the parkway. However, I see a lot less of them in my neighborhood and never doing any speed enforcement in my neighborhood. I also love that they're posting updates on the Facebook page. It shows they're approachable, transparent, and truly invested in making Crofton a safe and welcoming place to live!
- 68. Trailer parked unhitched on Urby near the corner of Good Hope has not moved in over 12 months. No license visible. One flat tire. The cover is now rotting. Please remove.
- 69. Your programs have had a positive impact on our community. My children have a positive view of the Crofton PD based on their visits to the school, the Cub Scout visits to the station, the trunk or treat event and the dunk event at city hall last year. The Crofton pd is doing the best they can with the resources and staffing available to them. I am proud to have this department in our community and appreciate all the work they do to keep our community safe and resilient.
- 70. Keep doing what you are doing. Most people are home at night and aren't worried about crimes like robberies of citizens. Burglaries during the day can be confronted with constant patrols when your patrol units are on duty. If theft from autos begins, which is mainly on midnights, maybe someone's shift can be changed to combat crime.
- 71. More night patrols for crime that occurs after hours, such as break-ins, and more traffic enforcement at all hours
- 72. I would love to have weekend coverage (not sure if we do) on Crofton Parkway.
- 73. I think you guys do a great job, but I think you should patrol 24/7, and it would be nice if you guys could patrol ALL of Crofton, like outside the triangle, such as Crofton Meadows, Chapman Farms, Waldon, etc. If that means charging more taxes for those neighborhoods, I'm all for it.
- 74. "Red Cross CPR/First Aid training, Bike safety demonstration, and bike checks. Program for Seniors- safety"
- 75. "Please publish the crimes occurring so we can be on the lookout. I've also reported crime and copied Crofton PD with no response. Not a good sign that crime is taken seriously. Speeding is a huge factor in our section and our block and surrounding must live with the daily weed smoking from one house, which is so bad you can't even go for a walk or sit outside. They do it in their yard and in their cars and then drive them. With little kids in the house. So dangerous, but the police never come. Never see police in our neighborhood, but it's a major escape route to Rte. 3"
- 76. I understand why police favor public safety programs, but these programs should not be at the expense of stopping speeders on Urby Drive or on the Parkway.
- 77. Understanding that AACO PD also covers Crofton I think it is disappointing that CPD does not appear to visibly increase patrol and does not patrol during the evenings. There has been an increase in car thefts and breakins; these people could be deterred if officers were visible and present. I appreciate their involvement in the schools and assisting crossing guards, but visibility and more frequent patrol would be preferred.

- 79. I feel safe here. The more police, the better. It definitely deters criminals. I know because I work in DC, and coming home to a safe haven like Crofton is such a blessing.
- 80. I have been a resident of Crofton Meadows my entire life. I am 43 now and also an African American. I hope with the rise of more African Americans I see living in the community that everyone is treated with respect and fairness. I say this because I was followed all the way into my cul-de-sac years ago by Crofton police because of a profiling measure, the officer literally stopped me in front of my home and asked what I was doing and where I was going. When I showed him my license and they saw my address they tried to paint a picture that I did not use my turn signal inside my neighborhood. I was 25 and this scarred be for almost 20 years. I have a 6-year-old son, and I never want him or anyone who rightfully lives here to ever experience that ever!!
- 81. We have lived in Crofton since 2001. I used to see officers parked along the parkway and cruising the streets. I used to see more speeding enforcement. In the last two years, there has been a significant increase in people driving too fast on Crofton Parkway (especially during the morning and evening commuting hours). Drivers are often rude and tailgate because of the lack of speed enforcement. If I remember correctly, officers would often provide a warning, which was a nice courtesy. I'm sure repeat offenders received tickets. We also used to see more officers, cruising by the parks which discouraged large groups of teenagers from congregating.
- 82. Consider parking your cruisers somewhere else sometimes. Every criminal in town can drive by the town hall and the 1 corporal's residence in about 2 minutes and know whether anyone is working or not. Also, please try to step up traffic enforcement again, it seems to have gone down in recent months. Yes, no one likes getting pulled over but it does do a good job of reducing speeding, running the stop signs, and helping find other crimes.
- 83. Maybe get out of the cars every once in a while and walk a block or two, say hello and talk to residents. Maybe get a couple e-bikes to show their presence.
- 84. Thank you!
- 85. I am so happy to see this survey. We need coverage 24/7.
- 86. None
- 87. We would love to see overnight coverage. It would make me and my family feel much safer, and ensure fewer incidents during evening and nighttime hours. We would absolutely pay more taxes to have more coverage 24/7. We love Crofton PD and truly appreciate all they do!!
- 88. "To be honest, I'm concerned for the safety of the children in our community. People speed up and down the parkway and side streets. If you happen to go the speed limit, the person behind you rides your bumper. I grew up here in Crofton. The laws are not enforced like they once were, and it makes it unsafe for our kids."
- 89. That new pickup truck is a waste of taxpayers' money. Also, what happened to the bikes we bought years ago. Officers were supposed to be using them to be more visible.
- 90. The speeding traffic continues to be a concern.
- 91. I would like to see an officer stationed at all schools during the school year. Similar to the program based in Montgomery County.
- 92. If not already being done, publish the police department's crime and traffic statistic trends once or twice a year.
- 93. I believe that with the limited officers, they do a good job. However, with the kind of people who do harm I want more officers patrolling.

- 100. No, I appreciate you participating in community events when we're over on the parkway.
- 101. We know they have a large area to cover, but please make it to the Willows to do checks also Police presence has declined in the past several years. Vehicles are leaving rt 3 during rush hour and speeding around the parkway to beat the northbound back-ups. If police are unable to patrol the parkway, then a speed camera/s would be welcomed. (between Crofton Woods and Crofton Elementary, maybe across from Village Green) Many bikers and pedestrians are in the roadway
- 102. Speeding on Crofton Parkway between the Country Club and Crofton Woods. I have heard that speed humps cannot be put in on that stretch. Can a speed camera be out in?
- 103. We enjoy the community programs!
- 104. I would like to see more traffic enforcement. Cars drive very fast on Crofton Parkway. Parked commercial vehicles and trailers should not be permitted to park either.
- 105. Swann Park in the evening is a problem. Many parties in the woods with fires, alcohol, and drug use. I would love for Thursday, Friday, and Saturday random checks. If cars are parked on Swinbourne at night, then kids are there. Strong odor of Marijuana often.
- 106. Police are doing great. It would be very beneficial to put in speed bumps AND a speed camera on the parkway between the country club and Duke of Kent (going towards the elementary school from the country club. Our cars have been hit several times, and our kids cannot play outside because of the cut-through drivers from 3, trying to save time, which exceeds 45mph at times.
- 107. "Great job guys!
- 108. Sometimes I see kids on mini motorized "bikes" or scooters going as fast as the cars on the parkway. Is that illegal?"
- 109. Sell the House. Move to the village green.
- 110. They do an excellent job, thank you! I love seeing them patrol & am grateful for their traffic stops, etc. It keeps traffic in hand. I'd love to have 24/7 coverage. I think it would deter crime.
- 111. While National Night Out, Trunk or Treat, and women's self-defense programs are nice, parents with young families are looking for updated playground facilities, splash pads, picnic tables, benches, and walkways to get to green spaces. These are things we'd use on a regular basis instead of having a couple of events a year or extra officers.

- 117. "We live on Albermarle, and noticed a neighbor in one of the townhouses along the Parkway recently had their wheels stolen. Are there plans to ramp up patrols to prevent this from happening to others?
- 118. We were also concerned with the young man last year at the corner of the town hall who was dancing in his underwear and talking to people who walked by, so close to Crofton Elementary School. We know the police offered him assistance, but he appeared to be severely mentally ill. Was there anything more we could have done as a community to support him and get him the help he needed? We were concerned that he may be in a crisis state, particularly close to the elementary school, and he was there for weeks."
- 119. Get them to enforce parking and vehicle storage on the parkway. I have many friends who know my history and always asking me why they do not ticket abandoned / stored vehicles decorating the parkway. Its an eyesore. One friend told me they told him the law doesn't permit this? Worked for county police for 10 years, the law does permit this. You cannot leave a vehicle sit in same location for a year and not move it once. Seeing around stored boats and campers is a hazard to boot. They don't even enforce the people that park next to the no parking signs up by city hall.
- 120. The community events are great, especially trunk or treat.
- 121. Speed regulating humps near the W-section courts (Walleye Dr. to Waldorf Ct.) on Crofton Parkway would be a great addition. I have witnessed reckless driving through this area of Crofton.
- 122. "Definitely a fan of increased patrols. And thank you for your service!"
- 123. I would like a better understanding of services which the Crofton PD can provide (as mentioned the security checks, etc.) and how to request these services (who do I contact?).
- 124. "As a resident of Lake Louise townhomes & now also a business owner in the Priest Bridge Shopping Center, I am thankful EVERY day for the hard work & care that the Crofton Police has provided... you are keeping not only my family, but my ballet students & their families safe as well. THANK YOU SOOO MUCH!!
- 125. (When I moved to Crofton, my dad, being a US Capitol Police officer at the time, was only going to let me move to my first home where it was safe... this was a BIG reason I moved here in 2017)"
- 126. We have a neighbor who runs a dog kennel from her house. Despite neighbor complaints and lodging cases, the business continues. Dogs have escaped and charged people walking by. Children have been left to look after dogs who get into fights. It's too late now, but you can understand my skepticism that the poki vs s are helping.
- 127. Perhaps change the (Schedules). Less police hours during the early morning mid-afternoon daylight hours, and concentrate more on the late afternoon and evening hours till about 3:00 AM or so.
- 128. Traffic enforcement should be a high priority. Especially given the increased congestion on Route 3 over the last 15 years, many people (who are likely not residents of the CSCBD) appear to cut through the Triangle to avoid traffic. It is very common to be tailgated on the parkway, and twice I have had people illegally pass me at speeds well over the limit. That being said, I understand that limited resources must be prioritized.

There are no swings at Crofton Woods E.S. or Hardy Field. Crofton Park has swings, and they are constantly being used by kids.
- 7. Parks must be monitored since people have set fire to logs and trees in the park; alcohol cans are also left behind.
- 8. Adaptive equipment for children w/special needs cord vocabulary board for communication support.

- 59. I know this has been asked and idk the costs, but some sort of splash pad would be wonderful."
- 60. A picnic shelter with a grill and some picnic tables.
- 61. Better benches (the current ones at Hardy field lean--you can't put anything on them) and tables. Bigger structures and structures for both little and big kids, more space--less brush and remove some trees so it's not a mosquito infestation.

On Spring Green to the cul-de-sac, two large cherry tree limbs could knock you out while running or walking on the sidewalk. Seems you want the front of the country club to look good, but are not interested in all areas. Out of sight, out of mind. Drive around, walk around town streets. Black metal fence of Spring Green near the entrance and exit to the golf course is in need of repair.
- 7. The sand should be cleared from the ADA accessible sidewalk ramps at the intersection of Tarrytown Ave and the Parkway sidewalk near Urby, and the Parkway is also covered with sand.
- 8. They do the minimum to keep CCA happy. The land by my house is NOT maintained well.
- 9. Trash pick-up daily at Hardy, maintenance at Hardy daily, and remove festival lines on Parkway since Blossom Festival.
- 10. Lake Louise continues to need help.
- 11. More pet disposal bags.
- 12. The maintenance worker is vital and does a great job.
- 13. Mosquito and tick fogging.
- 14. Hiking trails, walking paths.
- 15. The street sweeping truck should maintain the drains to the sewer I see the trucks go, and apparently pick up no trash. Someone should clean the drains. I did it once and it is a lot of work, and the trash collected is not suitable for yard waste bags.
- 16. Ensuring sidewalks are clear of overgrowth (eg, section just north of First Baptist Church). Also, the area across Swann Park adjacent to the Golf course.
- 17. Would love to see ice skating allowed at Crofton Park pond when ice is thick enough (rare but does happen)
- 18. plant native, non-water-intensive flora. In fact, the less water we use, the better, so putting in desert-style landscaping would be great.
- 19. Just put out a map so we know exactly where they are.
- 20. On Tyrone Street, the circle at the end of the street has plants that should be torn out and replaced with grass for use by residents.
- 21. More covered trash cans with regular emptying would be nice.
- 22. I believe this is really the country club. But there are several areas along Crofton Parkway where poison ivy is encroaching on the sidewalk.
- 23. The bushes that line Crofton Parkway in front of the country club need to be trimmed as they are impeding the sidewalk.
- 24. Keep nudging the Crofton Country Club to take on regular maintenance of their property, which runs along both of their intersections with/on Eton Way. Over this spring and summer, their property has become overgrown with unsightly vegetation, including large patches of poison ivy. These areas remained unkempt with large swaths of vegetation for extended periods of time.

- 35. Also--the median area that splits Good Hope for a few yards--could the low, scraggly bushes be removed since they are dying? I know they try to keep that up with flowers and such. It would look better if the basic shrubbery that is the core of the landscaping should be replaced.
- 36. I know Town Hall is aware of the problem of overflowing trash from the baseball families at Hardy Field. I realize it's a dilemma. They think someone else is going to take out the trash but they need to. The neighborhood families who use the park do trash pickup periodically to assist but if the contracted maintenance worker could swing by more frequently it would be so helpful."
- 37. More permanent benches along the parkway. Bought with donations. With a plaque in honor of beloved.
- 38. Grass is not being maintained in the summer around Crofton Golf Club the walkways are overgrown with weeds /grass/trees on Swinburne Avenue near Swan Park and on Spring Green Avenue.
- 39. Perhaps maintaining the grassy areas a little bit better so they don't just become dirt patches, especially along the sidewalk. I'm thinking along the sidewalk near Swan Park.
- 40. Please consider adding some trash cans along the parkway; maybe it would make people stop throwing their trash and dog bags in the bushes.
- 41. Signage might be helpful (to label/mark common areas).
- 42. The parking lot at the country club is in dire need of repaving. It makes it really hard to go to events there when my kids are constantly tripping over potholes and my stroller is getting stuck on the thousands of acorns and other debris all over the place.
- 43. The fence and landscaping around the golf course always look terrible. Not sure if this is in CCA control, but any improvements there would help a lot. Town Hall could also use some serious improvements, and a separate substation for police officers would be amazing.
- 44. Enhance the walking path connecting The Willows to Tyrone. Many kids play in the wooded area off the path, as well as many adults walk their dogs and use this area to get exercise. I have maintained the area for a number of

- 52. Better maintenance of the country club to curb sections, especially near the derelict tennis courts (maybe this is a country club issue)."
- 53. Replanting new cherry blossom trees, as many have been removed due to age and health.
- 54. Stop street sweeping truck.
- 55. "Those signs for CCA events (like the ice cream social or dog show) you put in the median across from the country club create a blind spot when you are turning left to get onto Crawford towards 3 from the parkway. Please consider different placement.
- 56. Please consider wreaths or something festive in the Crofton brick facades as you enter for the holidays!!!"
- 57. Dog bag stations on Crofton Parkway
- 58. More and nicer landscaping in common areas. A paved walkway to and around the lake? More paved walkways to get to and from places. Make the common areas more walkable besides just the streets. Add a LOT of benches. People of all ages want to walk and to do that they want a paved pathways and benches--families, older people, people working from home, everyone wants to walk.
- 59. Focus on converting to a nature-friendly landscape that does not need to be mowed as frequently. Reduce the number/frequency of hours-long lawn/leaf blowing. When they do need to work, the trucks should be parked so they do not impede the flow of traffic.
- 60. Get the parkway cleaned up. Stored vehicles and trailers, campers, boats with trash from months gone by, are an eyesore and detract from the appearance.
- 61. Spend less money acquiring properties and more on finding uses for the existing properties where possible. Some of these could be used as the basis for a community center (Good Hope and Route 450 property).
- 62. The GRASS it's been awful for years & if we can't grow grass, let's plant some moss so at least it's green.

One idea is to create a walking path around that area. While adding a mulch path may be a few years off, the saplings are growing, and if we are going to put in a path, we should cull the path starting this winter. Do you think:

- 1. Yes, put the path in with some thoughts; pushing strollers is very popular. It's not possible to safely access the 'enclave' on foot or by wheel. A paved path at Lake Louise might get used.

(Q59) Is there a subject or issue that you think we should be proactive about? If so, please describe:

- 1. I agree heartily with the CSCBD advocating for extending the sidewalk to Bell Branch Park. Very needed and would open up to riding to go there.
- 2. Green space, pedestrian safety, and bicycle routes/safety parks and playgrounds.
- 3. Stopping the Parkway as a cut-through for Route 3 traffic by adding speed bumps/cameras.
- 4. Too late to stop all the development on Route 3. We have become a nightmare area to live in. Sad because it used to be so nice.
- 5. Encourage development of Village Green; Coffee shop? Deli? Restaurant? Ice Cream? Town Hall? Community Center?
- 6. Continue removing large parked vehicles, trailers, and boats from the parkway. Also notifying homeowners if their cars are parked on their lawns.
- 7. I do not think that the CSCBD should be advocating for a sidewalk to Bell Branch Park. There is little foot traffic between the community and the park.
- 8. Noise levels from blowers. Business vehicles such as "Micheles" are permanently parked advertising, and people who think trash cans are decorative.
- 9. Growth management, road safety, property (e.g., vehicle) crime.
- 10. Education-the possible relocation of Nantucket children reminds many of us of the splitting of the community between Arundel and South River, which was ridiculous!

- 29. "- less development along Route 3. The traffic is a deterrent to me going out sometimes :(
- 30. I don't know if "getting parking signage changed on the Parkway to reduce or move long-term parking of recreational vehicles" includes trailers that are non-hitched, but I have seen several non-hitched trailers around the Triangle and they are hard to spot at night *if* you are not familiar with the neighborhood or you're not paying attention. There is a trailer that is frequently parked on Layton on the right side, right near the right turn intersection with 424. Either that trailer, or a car, has been parked there for years, and I believe it's too close to the right turn onto 424."
- 31. Please continue to be proactive about improving community infrastructure and limiting further residential development in the area. Traffic, especially along Route 3, has become a major problem during commuting times.
- 32. A left turn light is very much in need at Davidsonville Road and Underwood. It is hazardous and often impossible to make a left onto Underwood. This is VERY overdue.
- 33. Ban all trailer and motorhome parking on all our streets. Ticket all out-of-state tags parked in the street.
- 34. Reducing development, both residential and commercial, particularly along Rt 3.
- 35. The vehicle traffic on Route 3 (north and southbound) has become atrocious and dangerous over the last 41 years since I moved to Crofton. I remember in the 1990's there was an advocacy group working with the County and State to address the congestion problem. It was bad then, 10 times worse now! One of the ideas was to limit development of commercial enterprises in the median strip and to build a by-pass to funnel through traffic outside of the local Crofton environment. What has happened? Is this unplanned and haphazard growth called progress? Who does it benefit?
- 36. Please continue advocating on development and Route 3 traffic, which heavily impacts our community.
- 37. I would like to see better enforcement of bylaws or updates. I grew up in Crofton and, to me, some parts look very "junky". In the past, it was not allowed to park trailers in front of your house for long periods of time. I would like to see that enforced. Additionally, I see some houses with a lot of "junk" or trash in their yard for everyone to see. These are not homes where the owners are now elderly and they cannot maintain yards like they used to. Thanks for taking the time to conduct a survey. When I no longer have to work full-time, I will volunteer on a committee. And thanks to all who volunteer to be on a committee.
- 38. "Soliciting and commercial Signage and vehicles parked on the parkway."
- 39. Trailer parked unhitched on Urby near the corner of Good Hope has not moved in over 12 months. No license visible. One flat tire. The cover is now rotting. Please remove.
- 40. Rt 3 overdevelopment, and the lack of Highway maintenance at our main entry on Crawford Blvd. The condition of Rt 3 at that intersection is atrocious!!!! It always "feels" and looks like crap!
- 41. Traffic calming, adding more pedestrian crossings to the parkway and 424, with road narrowing and pedestrian islands to increase visibility for pedestrians. Stopping theft and crime, especially with vehicles. Removing trailers and trucks from the parkway or requiring them to move for street cleaning or monthly. Connecting bike/walk trails
- 42. "1. Runners are not using the sidewalk but Crofton Parkway instead. They run at dawn and dusk (before work and after they get home from work) on the Parkway. I'm waiting for a runner to get injured or worse from this practice.

I could understand if there were no sidewalk, but there are sidewalks on both sides of the road. With lots of parked cars it's an obstacle course for a driver.

- 2. PLEASE, PLEASE ask the person who owns the trailer housing the two wave runners and the car to move his rig off of Crofton Parkway!! (This has been there forever and is just north of the right turn-off to Rte. 3, on the west side of Crofton Parkway.) If he lives in the townhouses, there is a service road/parking area back in there. Can he park his rig in there?
- 3. URBY DRIVE: Post a 25 MPH sign in both directions on Urby Drive. Drivers leave the Parkway and speed up, once past the elementary school and the traffic calming bump. They drive with no regard for residents who live on the street; they just want to get out to Defense Highway asap.
- 43. I would love to see the beautification of Urby Drive! I think we residents should clean and sweep the curbs of litter and fallen leaves from past years. I would love to see Yoshino Cherry trees planted in the median areas where there are no trees growing. (Since Urby is a main artery within the Triangle, connecting Crofton Parkway and Defense Highway, why not plant trees in the bald spots? The same consideration should be given to Duke of Kent, Twain Dr, Layton, and the other arteries which sustain so much traffic. These areas all need posted speed limits, more trees and speed bumps.)"
- 44. Updating the covenants and restrictions and exploring the potential of creating a community center.
- 45. I am definitely concerned about Route three development and the challenges involving traffic along Route three. Again, many people just passing through treat it like a raceway. I am also concerned about large groups hanging out in the Waugh Chapel shopping areas.
- 46. Please keep working to reduce the number of RVs and tractor-trailers on the parkway; it really makes things look trashy if they never move.
- 47. The increasing sound nuisance from the raceway and relatedly the safety on route 3 and other main routes of car street racing or blocking off the street for drag racing
- 48. Renovate Swann Park as soon as possible
- 49. HOA enforcement
- 50. Addressing or even partnering with the Crofton Country Club to improve the areas that are visible (and dilapidated) when you enter the parkway at that location. Perhaps the utilization of those areas (tennis courts, etc.) could help all parties.
- 51. Remove long-term parked cars, vans, and trucks from the parkway and side streets. Do not allow boats, jet skis, trailers, or box trucks to be parked long-term on and around Crofton Parkway. Fine (make money) and tow if not moved. It looks terrible. Patrol side streets as well and remove cars that are old and leaking fluids, and that are no longer operable.
- 52. Route 3 and Reidel Road intersection congestion and traffic accidents.
- 53. I've been trying to get the light on Crain SB at Davidsonville Rd, turning left onto 424, so that more than 3-4 cars can make it through a cycle for years. Never even received a response.
- 54. "I think the sidewalk to Bell Branch is a huge feat, requires reclaiming of private property, and leveling it is a very expensive task. I do not feel children should be walking on a sidewalk that far away from their home, even from the closest home within the district.
- 55. Crofton Parkway is a nice, scenic drive with the trees and cherry blossoms in the spring. However, due to community HOA rules and fewer rules in the tax district, it is a parking lot for trailers / RVs / commercial vehicles. This really ruins the feel of the community."

- 56. I agree with all of the mentioned agenda items and would, if asked, show up to endorse them. Especially limiting development and housing. I know the narrative is "housing crisis," but what they mean is "affordable housing crisis," which is true, but our area is not set up to be the type of community that can support affordable housing limited public transportation/no community services, i.e., daily food distribution, heating/cooling centers, community centers, etc. There is no need to shove housing into our zip code when the schools are not able to support more children, and the roadways are already so crowded. This is largely a county planning and zoning issue but the irresponsible development affects everyone.
- 57. Limit the Twin Rivers 55 and older community to the original contract instead of changing the zoning to single-family homes. The schools and infrastructure need to be established before the area becomes flooded with traffic.

- 59. Commercial and recreational vehicles parked on the parkway
- 60. Swann Park on Thursday, Friday, and Saturday. Regular teenager gathering in the woods after dark. Gatherings including fires, alcohol, and drugs. It would be nice to get random checks in the area. If there are cars parked on Swinburne after hours near the park, then they are teenagers in the park and woods
- 61. Long-term PARKING in the triangle is a disgrace. It is an eyesore and, more importantly, is becoming a big safety issue with visibility challenges
- 62. Street sweeping truck services should be stopped! Put the money into new cherry trees.
- 63. Please continue with the parking regulations around the parkway it's such an eyesore. As a runner, those jet skis on the trailer will get me killed one day, going around them. Also, parking on the parkway in front of the apartments to Swann Park is an issue buses, giant semi trucks, trailers, please please help beautify the parkway and keep it safe by making stricter parking regulations
- 64. While the parking signage has removed some of the long-term vehicles on the parkway closer to town hall--the trucks and jet skis have just moved down the parkway by the Country Club
- 65. The parking signage did not solve the problem; it just moved it a few blocks. You are advocating for sidewalks to a park, but we don't have full sidewalks along the parkway. What needs to be done is more information on what is being built along Rt3.
- 66. Parking on all streets, especially recreational vehicles.
- 67. Continue with the push for the sidewalks to Bell Branch
- 68. Building a community center
- 69. You did a nice job putting up some signs to address the long-term parking of recreational and marine vehicles on part of the parkway, but that just shifted the problem down the road. Not sure why we're taking a piecemeal approach to this, but I'm sure it's due to some regulation or somesuch. It's a real problem, especially the trailer that seems to permanently park a few PWCs by the exit to Crofton. It's an accident waiting to happen (and I hear it already has).
- 70. You cannot let them devastate the trees behind Walleye Dr and Carry Place. I had a friend do a casual appraisal, and without the trees, there would be an unobstructed view of Route 3 and even more traffic noise. He told me that my house would go from 430k to about 380k. Value is one thing, but quality of life would also suffer. The county folks only care about job security, and their project may keep them employed, but it will worsen our lives and our property values.
- 71. "The redesign of Crofton Park into a skate park is very disappointing. I already submitted commentary but would like to continue to have updates.

- 72. The intersection of Davidsonville and Duke of Kent has daily red light runs. Either a red light camera or an adjustment of the light timing should be considered.
- 73. A new crosswalk on Davidsonville at Riedel Rd would be a huge community benefit. It would connect the triangle to the library and provide a safe connection for getting to the farmers' market now that it's at the lot there. You currently have to walk pretty far in either direction (Duke of Kent or the High school which last I tried was not in service) to reach a cross and many people end up just running across Davidsonville with kids in tow."
- 74. The parking of LARGE commercial trucks, 30-foot straight trucks, tractor trailers, LARGE camping trailers, small camping trailers, UNSIGHTLY moving trucks with visible damage and peeling paint, old passenger cars on trailers, recreational boats, and single operator water vessels, ALL around Crofton Parkway needs to be addressed, AGAIN. The aesthetics of these vehicles and trailers are a bad look for the Crofton community and those vehicles take up valuable overflow parking for community members.
- 75. Houses/properties that need some upkeep throughout Crofton.
- 76. Making the triangle a gated community only available and accessible to residents
- 77. Advocate for a traffic light, or at least a pedestrian walk light at Layton and 424. And a calming bump on Layton.
- 78. Ask the State DPW to make the collection of roadside lawn signs more frequent. They cheapen the look of the area.
